

TOWN OF FARMINGTON
ORDINANCE # 185-05
DEFINING TOWN LIMITS

AN ORDINANCE of the Town of Farmington, Washington, defining and fixing the corporate limits of the Town of Farmington. This ORDINANCE supercedes ORDINANCE #78 dated August 2, 1971, and ORDINANCE #163-96, dated the 13th of May, 1996.

The Town Council of the Town of Farmington do ordain as follows:

The corporate limits of the Town of Farmington are hereby defined and fixed as follows:

In the Town of Farmington, Whitman County, Washington:

Commencing at a point on the east side of Section 31, Township 19 N., Range 46 E.W.M., said point being 1,548.58 feet, more or less, lying northerly along the east boundary of said Section 31, said point being a recognized and undisputed point on the boundary line of the Town of Farmington, Whitman County, Washington, and the True Point of Beginning; thence southerly along the east boundary of said Section 31 a distance of 220.00 feet to the northeast corner of the southeast quarter of the southeast quarter of said Section 31; thence continuing southerly along the east boundary of said Section 31 a distance of 77.00 feet; thence westerly a distance of 110.80 feet, more or less, to the west line of Fifth Street; thence southerly along the west line of Fifth Street to the southeast corner of Block 40, Farmington; thence westerly along the north line of Bridge Street to the southwest corner of Block 40, Farmington; thence southerly to the northwest corner of Block 41, Farmington; thence easterly along the south line of Bridge Street to the westerly line of Fifth Street and the northeast corner of Block 41, Farmington; thence southerly along the west line of Fifth Street to the northeast corner of Block 9, Farmington; thence easterly to a point on the east boundary of Section 6, Township 18 N., Range 46 E.W.M., said point lying 120.00 feet northerly of the north line of Lewis' Addition to the Town of Farmington; thence easterly 75.00 feet and parallel to the north side of said Lewis' Addition to a point lying 120.00 feet northerly of the north line of said Lewis' Addition; thence southerly 120.00 feet to the north line of said Lewis' Addition; thence easterly along the north side of said Lewis' Addition to the Washington-Idaho State Line; thence southerly along said State Line to the southeast corner of said Lewis' Addition; thence westerly along the south side of said Lewis' Addition to the east side of said Section 6, Township 18 N., Range 46 E.W.M.; thence southerly along the east side of said Section 6 to

the south side of Railroad Addition to the said Town of Farmington; thence westerly along the south side of said Railroad Addition to the north and south subdivision line of said Section 6, Township 18 N., Range 46 E.W.M.; thence northerly along said subdivision line to a point 41.1 feet north of the north line of West Main Street in said Town, being a point on the north line of Main Street of said Town produced westerly; thence easterly along the north line of Main Street of said Town produced westerly to the southwest corner of Block 30 in Mrs. Elizabeth Sheehan's Addition to said Town of Farmington; thence northerly along the west side of Blocks 30 and 31 in said addition to the northwest corner of said Block 31; thence northerly 320 feet on a line extended northerly from the west side of said Block 31 to a point on the south side of West Alder Street; thence easterly along the south line of West Alder Street to the northwest corner of Block 15, Farmington; thence northerly along the westerly line of Blocks 45 and 44 Farmington to the northwest corner of said Block 44; thence easterly along the south line of Bridge Street to the northeast corner of Block 43, Farmington; thence northerly along the west line of Third Street 60 feet to the southeast corner of Block 38, Farmington; thence easterly 80 feet to the southwest corner of Block 39, Farmington; thence northerly along the east line of Third Street to a point on the north line of the southeast quarter of the southeast quarter of Section 31, Township 19 N., Range 46 E.W.M.; thence westerly 737.3 feet along the north line of said southeast quarter of the southeast quarter of said Section 31 to the northwest corner of said southeast quarter of the southeast quarter of said Section 31; thence northerly 220 feet on a line perpendicular to the north line of said southeast quarter of the southeast quarter of said Section 31; thence easterly and parallel to the north line of said southeast quarter of the southeast quarter of said Section 31, to the True Point of Beginning.

This ORDINANCE shall be in full force and effective five (5) days after its passage, approval and publication.
