

TOWN OF FARMINGTON
RESOLUTION # 367-15
CALLING FOR ELECTION ON EXCESS LEVY PROPOSITIONS

WHEREAS: The TOWN COUNCIL OF THE TOWN OF FARMINGTON has determined that the Regular Levy for the TOWN OF FARMINGTON for the year 2016, will be insufficient to meet the ordinary and necessary operating expenses the TOWN expects to incur, especially in the Current Expense Fund and City Street Maintenance Fund.

WHEREAS: The TOWN COUNCIL has determined that the most expedient means of generating additional Revenue for the year 2016, is to initiate an Excess Tax Levy.

NOW THEREFORE: It is hereby resolved by the MAYOR AND COUNCIL OF THE TOWN OF FARMINGTON, WHITMAN COUNTY, WASHINGTON, as follows:

1. That the GENERAL ELECTION shall be held on November 3rd, 2015.
2. That the Clerk-Treasurer presents the necessary Ballot Titles to the WHITMAN COUNTY AUDITOR within the required time by Law.
3. The content of the proposed Ballot Titles for the aforementioned Special Levies be substantially as follows:

PROPOSITION #1

SHALL THE TOWN OF FARMINGTON LEVY A SPECIAL TAX OF \$ 12,000.00 AN ESTIMATED \$ 1.08 PER \$1,000 OF THE 2015 ASSESSED VALUATION, FOR CITY STREET MAINTENANCE FUND, FOR COLLECTION IN 2016, BE APPROVED?

SHALL THE TOWN OF FARMINGTON LEVY A SPECIAL TAX OF \$ 8,000.00 AN ESTIMATED \$ 0.72 PER \$1,000 OF THE 2015 ASSESSED VALUATION, FOR CURRENT EXPENSE FUND, FOR COLLECTION IN 2016, BE APPROVED?
